Exempt Consent Templates and Guidance ^[1]

Consent Form Templates

These templates are appropriate for studies that require **expedited or full committee review** ^[2]. There are **separate consent templates for exempt research** ^[1], which includes some research that involves educational tests, surveys, interviews or focus groups.

Please note:

- Review the Consent Guidelines and Standard Wording ^[3] before writing your consent form.
- Keep the upper right-hand corner blank and use at least a 1.25" top margin.
- See the NCNN Informed Consent Language Database ^[4] for lay language terms.

Humanitarian Use Device ^[15] ?You may also use the sponsor?s version of the consent form, as long as you modify it to identify the UCSF investigator's name, department, and local contact number and provide the contact number for the UCSF IRB (415-476-1814).	May 2016
VA Consent Form 10-1086 Template ^[16] ? See the SFVAMC page ^[17] for info on this form.
