Decision Tool: Does this study qualify as Exempt 1, 2, 3, or 4?

This guide provides:

- 1. Definitions of the 4 Exempt categories as defined by the revised Common Rule
- 2. Bullet points to highlight new criteria for qualifying for a specific category
- Questions that will be in the "Initial Screening Questions" section of the IRB application for each category, along with advisements (in bolded red and black) that will appear for specific answers. Many of the advisements indicate that a study does <u>not</u> meet the specified Exempt criteria, and provides instructions for how to proceed.

Important: You must **read and follow the instructions** in the **bolded red and black** advisements to ensure you are filling the application out correctly. Otherwise, the IRB will send the application directly back to you for correction, without review.

Category 1:

Research, conducted in established or commonly accepted educational settings, that specifically involves normal educational practices that are not likely to adversely impact students' opportunity to learn required educational content or the assessment of educators who provide instruction.

- Prisoners can be enrolled only incidentally, cannot be an intentionally targeted study population
- No interventions allowed
- Minors can be enrolled

Category 2:

Category 3:

Research involving benign behavioral interventions in conjunction with the collection of information from an adult subject through verbal or written responses (including data entry) or audiovisual recording.

- <u>Benign behavioral intervention</u> is defined as "brief in duration, harmless, painless, not physically invasive, not likely to have a significant adverse lasting impact on the subjects, and the investigator has no reason to think the subjects will find the interventions offensive or embarrassing" (<u>HHS</u>).
- Minors can NOT participate in Exempt 3 research
