### B. FWA Background

The FWA system requires each legally separate entity that engages <sup>[4]</sup> in federally-supported human subject research to obtain their own FWA. For example, if UCSF has a prime grant from a federal funder and part of the human subject work is a subcontract to an outside institution (including foreign institutions), the subcontractor must obtain an FWA number before the money can be awarded to that subcontractor.

## C. UCSF Affiliates

The following organizations are either formally affiliated with UCSF or have a close collaborative relationship with UCSF. As such they have designated the UCSF IRB(s) as their IRB(s) of record for most or all of their human subjects research:
