Based the type of study you have (e.g., brand new study, approved study that is not in iRIS yet, approved study that is in iRIS as a reliance, or study approved by an external IRB), this table provides guidance about what forms to submit and how to answer specific questions in iRIS, the UCSF IRB's online submission system.
